# The process is simple.

---

## Sign up

- Sign the Letter of Intent to enroll your organization in the Commercial Solutions Program.
- This authorizes CLEAResult to perform an on-site walkthrough and pay the incentive upon project completion.
- CLEAResult receives a W-9 and electric bill for the participating facility.

## Evaluate

- CLEAResult performs a pre-installation inspection to document and evaluate existing equipment.
- Only equipment that is pre-inspected prior to removal may be included in the project.

## Define

- CLEAResult provides recommended projects, paybacks and preliminary incentive calculations for you to consider.
- Define the scope and timeline of the project in an incentive application.
- NOTE: There is no guarantee that incentive funds are available upon project completion without a signed incentive application.

## Complete

- The partner completes the project either with an outside contractor or in-house staff.
- The partner notifies CLEAResult upon project completion.

## Inspect

- CLEAResult performs a post-installation inspection to document and evaluate the newly installed equipment.

## Enjoy

- AEP Texas (North Division) issues the incentive check within four to six weeks.
- Collect your incentive and enjoy long-term savings.
- NOTE: The incentive check is a live check made to the attention of the person who signed the Letter of Intent — it is not a discount on the monthly bill.

## AEP Texas (North Division) incentive table

- Air compressor: **\$0.05/kWh**
- Air infiltration — fixed fee:  
**\$10/door sweep, \$20/weatherstrip**
- Commercial kitchen: **\$0.04/kWh**
- HVAC — chiller: **\$0.05/kWh**
- HVAC — DX: **\$0.04/kWh**
- LED lighting: **\$0.05/kWh**
- Lighting: **\$0.04/kWh**
- Refrigeration: **\$0.05/kWh**
- Roofing: **\$0.04/kWh**
- VFDs on VAV on AHU: **\$0.05/kWh**
